Terms

- Authorized Users: individuals who are affiliated with an Institutional Licensee, for
 educational non-profit and for-profit Institutional Licensees (such as colleges, universities,
 and secondary schools), currently enrolled students, researchers affiliated and/or visiting
 under the terms of an agreement with the Institutional Licensee, full and part-time staff, onsite users physically present on the Institutional Licensee's premises, museums, libraries,
 foundations, government agencies, public library Institutional Licensees
- **Institutional subscribers**: Institutions with a static IP address who subscribed the journal.
- **Individual subscribers**: private subscribers with a static IP address.
- Content: back and current digital issues of the journal, Studi Musicali (1972-2009) and Studi Musicali-nuova serie (2010-).

Procedure for the activation of access

With reference to our Subscription terms, subscribers will both receive twice a year the printed issue of the journal and have full access to the online digital version of all years, until the last number issued, once they have provided to the publisher their static IP address that is necessary to browse the archive.
